FINAL ORDER CLARIFYING CERTIFICATION 1205

On July 10, 2015, the Government Supervisors Association of Florida/Office and Professional Employees International Union, Local 100 (Local 100), filed a unit clarification petition seeking to clarify a bargaining unit described in certification 1205 to include several classifications in the supervisory bargaining unit it represents. On August 18, the Commission-appointed hearing officer issued an order recommending that the Commission grant the petition. No exceptions to the recommended order were filed.

Upon consideration, and for the reasons articulated by the hearing officer, the petition is GRANTED. Certification 1205 is clarified as follows:

INCLUDED: All supervisory employees of the City of Miami Beach in the classifications of air conditioning supervisor, backflow coordinator, beach patrol operations supervisor, carpenter supervisor, central services supervisor,

city surveyor, communications supervisor, crime scene supervisor, electricían supervisor, electronics/instruments supervisor, fleet operations supervisor, lead mechanic, maintenance supervisor, metered service supervisor. paint supervisor, park operations supervisor, parking facilities supervisor, parking operations supervisor, plumbing supervisor, property management operations supervisor, pumping operations supervisor, recreation supervisor I, sanitation operations supervisor, senior building inspector, senior engineering inspector, service supervisor, sewer field operations supervisor, street lighting operations supervisor, street operations supervisor, tennis center supervisor, warehouse supervisor, water field operations supervisor, water service representative, 911 communications records custodian, code compliance supervisor, field supervisor, fire inspections supervisor, police financial assistant, police records supervisor, property/evidence supervisor, public safety payroll administrator, security specialist, and utility billing supervisor.

EXCLUDED: All other employees employed by the City of Miami

Beach

This order may be appealed to the appropriate district court of appeal. A notice of appeal must be received by the Commission and the district court of appeal within thirty days from the date of this order. Except in cases of indigency, the court will require a filling fee and the Commission will require payment for preparing the record on appeal. Further explanation of the right to appeal is provided in Sections 120.68 and 447.504, Florida Statutes (2015), and the Florida Rules of Appellate Procedure.


