I know you are very familiar with the Upper N. Bay Rd., Homeowner Association, as well as many residents who live here.

We have an extreme problem during the hours of 4 to 7 PM.

I am writing you as a former member of the association, and as a full-time resident.

Due to the 63rd St., bridge, raisings, and rush-hour traffic, Upper N. Bay Rd. has become an alternate route through which traffic gets diverted starting at approximately 54 street, but especially bad at 57th heading N and people race and run through stop signs and generally terrorize our neighborhood in an effort to avoid traffic.

Even though this has become common practice, we have not seen police be deployed, or any other traffic, calming measures or safety measures to protect our families. We need the police department to start protecting us.

57-63 is especially bad.

Joy Malakoff lives at the top which is at 63rd St. where they race around the tot park, trying to decide if they will go left at LaGorce Drive, or at Pinetree Circle.

Years ago we met with Clements and the then chief of police to discuss possibilities of adding signage on Alton: no left turn, during certain hours, no u turn etc. It would also be a great benefit to have certain streets be West or East only.

Also extremely dangerous is the 51st left hand turn from Lakeview.

We are aware that Alton is not a city road, but N. Bay Rd. is, and 51st St. is. The City is able to do what we want on our streets.

Surfside was very effective in managing and creating safe traffic control, traffic, calming measures, and improving the look and feel of the neighborhood without messing with the roads don't control.

We hope you will help us and at least get some police presence on NBR during the hours of 4 and 6 pm instead of just having speed traps on Alton. There is nothing more dangerous than people running. Stop signs and racing through our residential neighborhood.

Speeding on Alton isn't the big problem. Speeding on North Bay Road is.

Can you please help.
