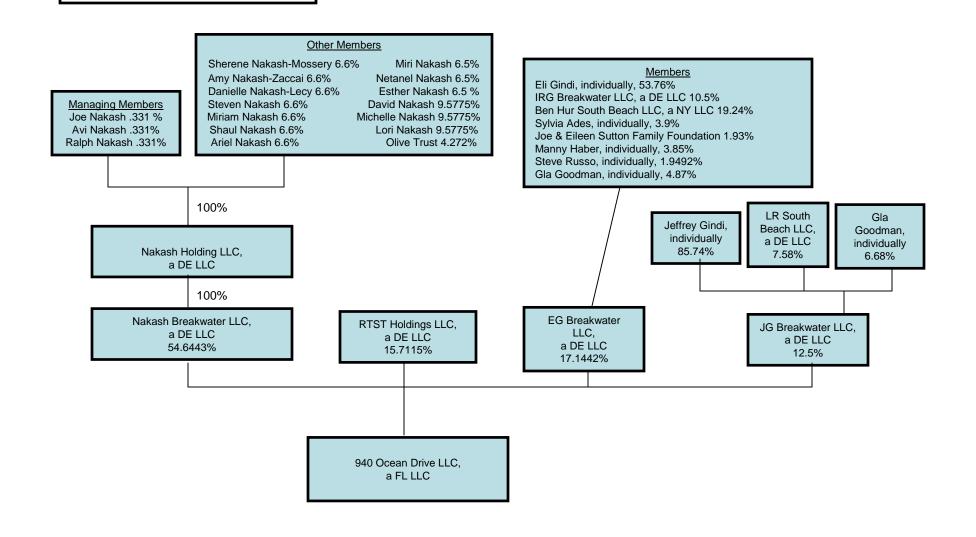

This law firm represents Sobe USA, LLC d/b/a Ocean's Ten South Beach (the "Applicant") with regard to the above-referenced property (the "Property"). Please let the following serve as the required letter of intent in connection with a request for a Certificate of Appropriateness for Design and Installation.

<u>Description of Property</u>. The Property is a four-story building, located on the corner of 10th Street and Ocean Drive. It is located in the MXE (Mixed Use Entertainment) zoning district and the Ocean Drive/Collins Avenue Local Historic District.

<u>The Property</u>. The Miami-Dade County Property Appraiser has assigned Folio No. 02-3234-008-0010 to the Property. The Property consist of approximately 25,423 square feet. Currently the Property houses restaurant and hotel uses.

In 1929, a one-story building, that served as a food store was constructed on the Property. That structure was never demolished, rather when Henry Hohauser designed the Edison Hotel in 1935, he incorporated the store building into the first-floor terrace, which still exists in the bar area.

The 1935 design of the Edison Hotel was of a four-story hotel. Its design has elements of both Mediterranean and Art Deco architectural styles, and can be

classified as Med-Deco Transitional. Notable features on the east façade are the "layered" setbacks, the three stories-tall twisted columns, rounded arches, decorated parapet, and faux balcony. The hotel entrance and lobby face north on 10th Street, where the façade features more twisted columns, a bracketed balcony, and a triple-arched vestibule.

Development Program. The applicant is seeking a Certificate of Appropriateness (COA) for proposed awnings along the front façade of the Property. This proposed design would be an upgrade to the existing awning in terms of aesthetics and function, and will require minimal demolition for installation. Also, the awnings respect the architectural lines of the existing design. The Existing arches provide a horizontal feature, which the awnings will follow. The new awnings' design requires no frontal support, and provides for uninterrupted panoramic views for both the public and patrons of the Property. The awnings are mechanically operated, retractable canopies that are usable in all weather conditions. Most importantly, the proposed awnings are in line with the overall feel being sought by the Ocean Drive Task Force and the Ocean Drive Sidewalk Café Guidelines, which were put together by the Mayor and City Commission to rehabilitate the aesthetics of the Ocean Drive neighborhood.

Conclusion. The Applicant seeks approval of a Certificate of Appropriateness for design and installation of new front awnings. The proposed design will not only enhance the appearance of the Property and surrounding area, but it is also consistent with the Task Force's and the City Commission's objective of having low profile canopies, that provide a cleaner, more consistent, and brighter appearance while mitigating the dark conditions on the sidewalks. The installation of the modern front awnings will help the Property keep pace with the great evolution occurring in Miami Beach and encourage the rest of the Ocean Drive MXE district to do the same.
