SUBJECT: HPB22-0560, **663 Alton Road**.

An application has been filed requesting a Certificate of Appropriateness for the construction of a new public library and health clinic on an existing surface parking

lot.

RECOMMENDATION

Approval of the Certificate of Appropriateness with conditions.

BACKGROUND

On August 23, 2022, the electorate approved an FAR increase for the Alton Road Gateway Area as part of a larger development proposal that would relocate the existing Miami-Dade County community health center from its current location on the west side of Alton Road (710 Alton Road) across the street to the southeast corner of Alton Road and 7th Street (663 Alton Road) to accommodate a new mixed-use structure to the north and east of the existing park.

On February 1, 2023, the City Commission referred an ordinance amendment (item C4 AF) to the Land Use and Sustainability Committee (LUSC) and the Planning Board that would accommodate the new community health center and library facility including building setbacks and pharmacy regulations. This ordinance is currently pending before the LUSC.

COMPLIANCE WITH ZONING CODE

A preliminary review of the project indicates that the application appears to be consistent with the City Code with the exception of waivers requested pursuant to Section 142-425 of the City Code, pending City Commission review.

Any projections into the right-of-way require a revokable permit to be reviewed and approved by the Public Works Department and the City Commission.

This shall not be considered final zoning review or approval. These and all zoning matters shall require final review and verification by the Zoning Administrator prior to the issuance of a Building Permit.

ANALYSIS

The subject site is located within the CD-2 zoning district along the east side of Alton Road, within the westward expansion of the Flamingo Park Local Historic District, designated in 2008. One of the goals in expanding the Flamingo Park Historic District was to protect the character of the adjacent residential properties to the east. After adoption of the expanded historic district, the Alton Road Historic Buffer Overlay District was created in 2014. The overlay district regulations

are intended to achieve a more compatible relationship of scale and massing between the Alton Road corridor and the adjoining residential neighborhoods, to promote mixed-use development that makes efficient use of parking, to minimize the concentration of impacts from intense retail and restaurant development and to encourage smaller neighborhood-oriented uses.

The applicant is currently requesting approval to build a 2-story mixed-use building containing a public library facility and a community health center. It is important to note that this project is being proposed in conjunction with a larger development on the west side of Alton Road (outside of the Flamingo Park Historic District) which includes the relocation of the existing Miami-Dade County community health center from its current location on at 710 Alton Road.

Staff is supportive of the application and would commend the applicant for proposing to construct a high-quality structure to replace the existing surface parking lot. Over time, the parking lot has had an increasingly adverse impact on the context and character of this portion of the Flamingo Park Historic District. The overall design concept has been well developed when evaluated within the entirety of its surrounding context. In this regard, the contemporary architectural vocabulary responds well to the 4-story self-storage building to the south and a 4-story medical center to the north. Further, the scale and massing of the proposed project is highly responsive to the adjacent, low scale residential portion of the Flamingo Park Historic District. Staff would also note that the proposed height of 26'-5" is substantially lower that the allowable height of 50'-0" for the Alton Road portion.

Finally, staff would note that the applicant is proposing to relocate several of the existing live oak trees to the Alton Road right-of-way which will significantly improve the quality of the pedestrian experience. In summary, staff is highly supportive of the application which will provide a state-of-the-art health center and public library for the community and recommends approval as noted below.

RECOMMENDATION

In view of the foregoing analysis, staff recommends the application, be **approved** subject to the conditions enumerated in the attached draft Order, which address the inconsistencies with the aforementioned Certificate of Appropriateness and Practical Difficulty and Hardship criteria, as applicable.

In this regard, the contemporary architectural vocabulary responds well to the 4-story self-storage building to the south and a 4-story medical center to the north. Further, the scale and massing of the proposed project is highly responsive to the adjacent, low scale residential portion of the Flamingo Park Historic District. Staff would also note that the proposed height of 26'-5" is substantially lower that the allowable height of 50'-0" for the Alton Road portion.

Finally, staff would note that the applicant is proposing to relocate several of the existing live oak trees to the Alton Road right-of-way which will significantly improve the quality of the pedestrian experience. In summary, staff is highly supportive of the application which will provide a state-of-the-art health center and public library for the community and recommends approval as noted below.

RECOMMENDATION

In view of the foregoing analysis, staff recommends the application, be **approved** subject to the conditions enumerated in the attached draft Order, which address the inconsistencies with the aforementioned Certificate of Appropriateness and Practical Difficulty and Hardship criteria, as applicable.

The City of Miami Beach Historic Preservation Board makes the following FINDINGS OF FACT, based upon the evidence, information, testimony and materials presented at the public hearing and which are part of the record for this matter:

I. Certificate of Appropriateness

- A. The subject site is located within the Flamingo Park Local Historic District.
- B. Based on the plans and documents submitted with the application, testimony and information provided by the applicant, and the reasons set forth in the Planning Department Staff Report, the project as submitted:
 - 1. Is consistent with Sea Level Rise and Resiliency Review Criteria in Section 133-50(a) of the Miami Beach Code.
 - 2. Is consistent with Certificate of Appropriateness Criteria in Section 118-564(a)(1) of the Miami Beach Code.
 - 3. Is consistent with Certificate of Appropriateness Criteria in Section 118-564(a)(2) of the Miami Beach Code.
 - 4. Is not consistent with Certificate of Appropriateness Criteria 'b' in Section 118-564(a)(3) of the Miami Beach Code.

- C. The project would be consistent with the criteria and requirements of section 118-564 and 133-50(a) if the following conditions are met:
 - 1. Revised elevation, site plan and floor plan drawings shall be submitted and, at a minimum, such drawings shall incorporate the following:
 - a. Final details of all exterior surface finishes and materials, including samples, shall be submitted, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
 - b. All roof-top fixtures, air-conditioning units and mechanical devices shall be clearly noted on a revised roof plan and elevation drawings and shall be screened from view, in a manner to be reviewed and approved by staff, consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
 - 2. A revised landscape plan, prepared by a Professional Landscape Architect, registered in the State of Florida, and corresponding site plan, shall be submitted to and approved by staff. The species type, quantity, dimensions, spacing, location and overall height of all plant material shall be clearly delineated and subject to the review and approval of staff. At a minimum, such plan shall incorporate the following:
 - a. A fully automatic irrigation system with 100% coverage and an automatic rain sensor in order to render the system inoperative in the event of rain.
 - b. The project design shall minimize the potential for a project causing a heat island effect on site.
 - c. Cool pavement materials or porous pavement materials shall be utilized, if applicable.

In accordance with Section 118-537, the applicant, the owner(s) of the subject property, the City Manager, Miami Design Preservation League, Dade Heritage Trust, or an affected person may appeal the Board's decision on a Certificate of Appropriateness to a special master appointed by the City Commission.

II. Variance(s)

A. No variances have been requested as part of this application.

The decision of the Board regarding variances shall be final and there shall be no further review thereof except by resort to a court of competent jurisdiction by petition for writ of certiorari.

III. General Terms and Conditions applying to both 'I. Certificate of Appropriateness' and 'II. Variances' noted above.

- A. The applicant agrees and shall be required to provide access to areas subject to this approval (not including private residences or hotel rooms) for inspection by the City (i.e.: Planning, Code Compliance, Building Department, Fire Safety), to ensure compliance with the plans approved by the Board and conditions of this order.
- B. The issuance of a building permit is contingent upon meeting Public School Concurrency requirements, if applicable. Applicant shall obtain a valid School Concurrency Determination Certificate (Certificate) issued by the Miami-Dade County Public Schools. The Certificate shall state the number of seats reserved at each school level. In the event sufficient seats are not available, a proportionate share mitigation plan shall be incorporated into a tri-party development agreement and duly executed. No building permit may be issued unless and until the applicant obtains a written finding from Miami-Dade County Public Schools that the applicant has satisfied school concurrency.
- C. The relocation of any tree shall be subject to the approval of the Environment & Sustainability Director and/or Urban Forester, as applicable.
- D. Where one or more parcels are unified for a single development, the property owner shall execute and record a unity of title or a covenant in lieu of unity of title, as may be applicable, in a form acceptable to the City Attorney.
- E. A copy of all pages of the recorded Final Order shall be scanned into the plans submitted for building permit and shall be located immediately after the front cover page of the permit plans.
- F. The Final Order shall be recorded in the Public Records of Miami-Dade County, prior to the issuance of a Building Permit.
- G. Satisfaction of all conditions is required for the Planning Department to give its approval on a Certificate of Occupancy; a Temporary Certificate of Occupancy or Partial Certificate of Occupancy may also be conditionally granted Planning Departmental approval.
- H. The Final Order is not severable, and if any provision or condition hereof is held void or unconstitutional in a final decision by a court of competent jurisdiction, the order shall be returned to the Board for reconsideration as to whether the order meets the criteria for approval absent the stricken provision or condition, and/or it is appropriate to modify the remaining conditions or impose new conditions.
- I. The conditions of approval herein are binding on the applicant, the property's owners, operators, and all successors in interest and assigns.
- J. Nothing in this order authorizes a violation of the City Code or other applicable law, nor allows a relaxation of any requirement or standard set forth in the City Code.
- K. Upon the issuance of a final Certificate of Occupancy or Certificate of Completion, as applicable, the project approved herein shall be maintained in accordance with the plans approved by the board and shall be subject to all conditions of approval herein, unless otherwise modified by the Board. Failure to maintain shall result in the issuance of a Code

Compliance citation, and continued failure to comply may result in revocation of the Certificate of Occupancy, Completion and Business Tax Receipt.

IT IS HEREBY ORDERED, based upon the foregoing findings of fact, the evidence, information, testimony and materials presented at the public hearing, which are part of the record for this matter, and the staff report and analysis, which are adopted herein, including the staff recommendations, which were amended and adopted by the Board, that the application is GRANTED for the above-referenced project subject to those certain conditions specified in Paragraph I, II, III of the Findings of Fact, to which the applicant has agreed.

PROVIDED, the applicant shall build substantially in accordance with the plans entitled "Alton Health Clinic-Library", as prepared by Built Form, LLC, dated December 20, 2022, as approved by the Historic Preservation Board, as determined by staff.

When requesting a building permit, the plans submitted to the Building Department for permit shall be consistent with the plans approved by the Board, modified in accordance with the conditions set forth in this Order. No building permit may be issued unless and until all conditions of approval that must be satisfied prior to permit issuance, as set forth in this Order, have been met.

The issuance of the approval does not relieve the applicant from obtaining all other required Municipal, County and/or State reviews and permits, including final zoning approval. If adequate handicapped access is not provided on the Board-approved plans, this approval does not mean that such handicapped access is not required. When requesting a building permit, the plans submitted to the Building Department for permit shall be consistent with the plans approved by the Board, modified in accordance with the conditions set forth in this Order.

If the Full Building Permit for the project is not issued within eighteen (18) months of the meeting date at which the original approval was granted, the application will expire and become null and void, unless the applicant makes an application to the Board for an extension of time, in accordance with the requirements and procedures of Chapter 118 of the City Code; the granting of any such extension of time shall be at the discretion of the Board. If the Full Building Permit for the project should expire for any reason (including but not limited to construction not commencing and continuing, with required inspections, in accordance with the applicable Building Code), the application will expire and become null and void.

In accordance with Chapter 118 of the City Code, the violation of any conditions and safeguards that are a part of this Order shall be deemed a violation of the land development regulations of the City Code. Failure to comply with this Order shall subject the application to Chapter 118 of the City Code, for revocation or modification of the application.
