SUBJECT: HPB23-0569, Meridian Avenue between Lincoln Road and North Lincoln Lane

and Drexel Avenue between 16th Street and North Lincoln Lane – <u>Lincoln</u> Road Master Plan – Meridian Avenue and Drexel Avenue Right-of-Way

<u>Improvements</u>.

An application has been filed requesting a Certificate of Appropriateness for right-

of-way improvements as part of the Lincoln Road Master Plan.

STAFF RECOMMENDATION

Approval of the Certificate of Appropriateness with conditions.

BACKGROUND

On November 10, 2015, the Historic Preservation Board reviewed and approved a Certificate of Appropriateness for the design of the Lincoln Road Master Plan (HPB 7585).

On June 19, 2017 and October 10, 2017, the Board reviewed and approved modifications to the previously issued Certificate of Appropriateness including design and lighting modifications (HPB17-0117).

EXISTING SITE

Local Historic District: Flamingo Park

ZONING / SITE DATA

Legal Description: A portion of the Meridian Avenue public right-of-way

bounded by Lincoln Road to the south and Lincoln Lane North to the north and a portion of the Drexel Avenue public right-of -way bounded by 16th Street to the south and North Lincoln Lane to the north, all lying and being in the City of

Miami Beach, Florida.

THE PROJECT

The applicant has submitted plans entitled "Lincoln Road District", as prepared by James Corner Field Operations, dated March 6, 2023.

COMPLIANCE WITH ZONING CODE

A preliminary review of the project indicates that the application appears to be consistent with the City Code. This shall not be considered final zoning review or approval. These and all zoning matters shall require final review and verification by the Zoning Administrator prior to the issuance of a Building Permit.

CONSISTENCY WITH 2040 COMPREHENSIVE PLAN

A preliminary review of the project indicates that the project is **consistent** with the Future Land Use Map of the Comprehensive Plan.

COMPLIANCE WITH SEA LEVEL RISE AND RESILIENCY REVIEW CRITERIA

Section 133-50(a) of the Land Development establishes review criteria for sea level rise and resiliency that must be considered as part of the review process for board orders. The following is an analysis of the request based upon these criteria:

- (1) A recycling or salvage plan for partial or total demolition shall be provided. **Not Applicable**
- (2) Windows that are proposed to be replaced shall be hurricane proof impact windows.

- (3) Where feasible and appropriate, passive cooling systems, such as operable windows, shall be provided.

All buildings shall have, to the greatest extent possible, space in that part of the ground floor fronting a sidewalk, street or streets which is to be occupied for residential or commercial uses; likewise, the upper floors of the pedestal portion of the proposed building fronting a sidewalk street, or streets shall have residential or commercial spaces, or shall have the appearance of being a residential or commercial space or shall have an architectural treatment which shall buffer the

appearance of a parking structure from the surrounding area and is integrated with the overall appearance of the project.

I. All buildings shall have an appropriate and fully integrated rooftop architectural treatment which substantially screens all mechanical equipment, stairs and elevator towers.

STAFF ANALYSIS

Since its inception, Lincoln Road has served as a retail and social center for the City of Miami Beach. In 1960, eight blocks of the road were closed to vehicular traffic and converted to a pedestrian mall. Designed by architect Morris Lapidus, the key elements of the 1960 plan include:

- A central spine marked by the distinctive 'piano key' paving
- A series of geometrically distinctive planted gardens, water features and seat-walls
- Sculptural follies situated on the central spine
- A wide pedestrian promenade along the storefronts
- A lush vegetation composed of low understory and high canopy trees

Through the 1980s, the original Lapidus plan fell into disrepair; plantings and hardscape slowly deteriorated. In the mid-1990s, the pedestrian mall was renovated and modified including additional landscaping, the introduction of bollards and lighting, and a new paving pattern.

In 2015, the Historic Preservation Board reviewed and approved a Certificate of Appropriateness for the Lincoln Road Master Plan. The approved plan served as the basis for future improvements to Lincoln Road and included lighting, pedestrian surfaces, street furnishings, and landscaping as well as the restoration of the folly structures. Further, the Board approved modifications to the master plan in 2017. Subsequently, the design continued to be developed to incorporate feedback from regulatory agencies and the final design was delivered to the City in early 2020; however, due to the COVID-19 pandemic, the City postponed the project. In 2022, the scope of work was refined by the City including modifications to minimize impacts to Lincoln Road businesses.

To begin work as expeditiously as possible, the City currently requesting the Board review modified designs for the Meridian and Drexel Avenue portions of the plan. The remainder of the modified Lincoln Road master plan will be submitted for Board review in the near future.

Meridian Avenue (between Lincoln Road and Lincoln Lane North)

The proposed design for Meridian Avenue is generally consistent with the previous approved design and includes the enlargement of sidewalks, the introduction of new street trees and café dining zones, and bikes lanes improvements. This will be accomplished by the removal of the painted median, allowing for the traffic lanes to be consolidated within the center of the right-of-way. A new sidewalk pavement treatment is proposed to be introduced consisting of precast concrete pavers with exposed shell aggregate in four colors. The colors proposed are meant to complement the existing Lincoln Road pavement design introduced in the 1990s, which will be retained.

Drexel Avenue (between 16th Street and Lincoln Lane North)

The proposed plan for Drexel Avenue is substantially consistent with the previously approved design including, the pedestrianization of the right-of-way between approximately 1620 Drexel Avenue and Lincoln Lane North. The modifications are primarily limited to the introduction of a new pavement plan. This new pavement design incorporates colored concrete pavers similar to the Meridian Avenue design as well as, black and white pavers within the Lincoln Road intersection complementing the existing 'piano key' pavement to remain to the north and south.

Finally, staff would note that the proposed street and pedestrian lighting fixtures, street furniture and wayfinding signage are all substantially consistent with the previously approved master plan. In summary, staff is supportive of the revised designs for these two portions of the project and recommends approval as noted below.

RECOMMENDATION

In view of the foregoing analysis, staff recommends that the request for a Certificate of Appropriateness be **approved**, subject to the conditions enumerated in the attached draft Order.

ORDER

The City of Miami Beach Historic Preservation Board makes the following FINDINGS OF FACT, based upon the evidence, information, testimony and materials presented at the public hearing and which are part of the record for this matter:

I. Certificate of Appropriateness

- A. The subject site is located within the Flamingo Park Local Historic District.
- B. Based on the plans and documents submitted with the application, testimony and information provided by the applicant, and the reasons set forth in the Planning Department Staff Report, the project as submitted:
 - 1. Is consistent with Sea Level Rise and Resiliency Review Criteria in Section 133-50(a) of the Miami Beach Code.
 - 2. Is consistent with Certificate of Appropriateness Criteria in Section 118-564(a)(1) of the Miami Beach Code.
 - 3. Is consistent with Certificate of Appropriateness Criteria in Section 118-564(a)(2) of the Miami Beach Code.
 - 4. Is consistent with Certificate of Appropriateness Criteria in Section 118-564(a)(3) of the Miami Beach Code.
- C. The project would remain consistent with the criteria and requirements of section 118-564 and 133-50(a) if the following conditions are met:

- 1. Revised elevation, site plan and floor plan drawings shall be submitted and, at a minimum, such drawings shall incorporate the following:
 - a. The final design and details of all exterior paving, including material, dimensions and finishes shall be provided, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
- 2. A revised landscape plan, prepared by a Professional Landscape Architect, registered in the State of Florida, and corresponding site plan, shall be submitted to and approved by staff. The species type, quantity, dimensions, spacing, location and overall height of all plant material shall be clearly delineated and subject to the review and approval of staff. At a minimum, such plan shall incorporate the following:
 - a. All existing, healthy canopy trees shall be retained to the greatest extent possible, subject to the review and approval of the Urban Forester.
 - b. The utilization of root barriers and/or Silva Cells, as applicable, shall be clearly delineated on the final revised landscape plan.
 - c. A fully automatic irrigation system with 100% coverage and an automatic rain sensor in order to render the system inoperative in the event of rain. Right-of-way areas shall also be incorporated as part of the irrigation system.
 - d. The project design shall minimize the potential for a project causing a heat island effect on site.
 - e. Cool pavement materials or porous pavement materials shall be utilized, if applicable.

In accordance with Section 118-537, the applicant, the owner(s) of the subject property, the City Manager, Miami Design Preservation League, Dade Heritage Trust, or an affected person may appeal the Board's decision on a Certificate of Appropriateness to a special master appointed by the City Commission.

II. Variance(s)

A. No variances have been requested as part of this application.

The decision of the Board regarding variances shall be final and there shall be no further review thereof except by resort to a court of competent jurisdiction by petition for writ of certiorari.

- III. General Terms and Conditions applying to both 'I. Certificate of Appropriateness' and 'II. Variances' noted above.
 - A. The applicant agrees and shall be required to provide access to areas subject to this approval (not including private residences or hotel rooms) for inspection by the City (i.e.:

Planning, Code Compliance, Building Department, Fire Safety), to ensure compliance with the plans approved by the Board and conditions of this order.

- B. The issuance of a building permit is contingent upon meeting Public School Concurrency requirements, if applicable. Applicant shall obtain a valid School Concurrency Determination Certificate (Certificate) issued by the Miami-Dade County Public Schools. The Certificate shall state the number of seats reserved at each school level. In the event sufficient seats are not available, a proportionate share mitigation plan shall be incorporated into a tri-party development agreement and duly executed. No building permit may be issued unless and until the applicant obtains a written finding from Miami-Dade County Public Schools that the applicant has satisfied school concurrency.
- C. The relocation of any tree shall be subject to the approval of the Environment & Sustainability Director and/or Urban Forester, as applicable.
- D. Where one or more parcels are unified for a single development, the property owner shall execute and record a unity of title or a covenant in lieu of unity of title, as may be applicable, in a form acceptable to the City Attorney.
- E. A copy of all pages of the recorded Final Order shall be scanned into the plans submitted for building permit and shall be located immediately after the front cover page of the permit plans.
- F. All applicable FPL transformers or vault rooms and backflow prevention devices shall not be located within the required setbacks with the exception of the valve (PIV) which may be visible and accessible from the street.
- G. The Final Order shall be recorded in the Public Records of Miami-Dade County, prior to the issuance of a Building Permit.
- H. Satisfaction of all conditions is required for the Planning Department to give its approval on a Certificate of Occupancy; a Temporary Certificate of Occupancy or Partial Certificate of Occupancy may also be conditionally granted Planning Departmental approval.
- I. The Final Order is not severable, and if any provision or condition hereof is held void or unconstitutional in a final decision by a court of competent jurisdiction, the order shall be returned to the Board for reconsideration as to whether the order meets the criteria for approval absent the stricken provision or condition, and/or it is appropriate to modify the remaining conditions or impose new conditions.
- J. The conditions of approval herein are binding on the applicant, the property's owners, operators, and all successors in interest and assigns.
- K. Nothing in this order authorizes a violation of the City Code or other applicable law, nor allows a relaxation of any requirement or standard set forth in the City Code.
- L. Upon the issuance of a final Certificate of Occupancy or Certificate of Completion, as applicable, the project approved herein shall be maintained in accordance with the plans

approved by the board and shall be subject to all conditions of approval herein, unless otherwise modified by the Board. Failure to maintain shall result in the issuance of a Code Compliance citation, and continued failure to comply may result in revocation of the Certificate of Occupancy, Completion and Business Tax Receipt.

IT IS HEREBY ORDERED, based upon the foregoing findings of fact, the evidence, information, testimony and materials presented at the public hearing, which are part of the record for this matter, and the staff report and analysis, which are adopted herein, including the staff recommendations, which were amended and adopted by the Board, that the application is GRANTED for the above-referenced project subject to those certain conditions specified in Paragraph I, II, III of the Findings of Fact, to which the applicant has agreed.

PROVIDED, the applicant shall build substantially in accordance with the plans entitled "Existing Interior Storefront Change Door for a Frameless Interior Glass Door, Breakwater Hotel", prepared by Sklarchitecture, dated May 12, 2020, as approved by the Historic Preservation Board, as determined by staff.

When requesting a building permit, the plans submitted to the Building Department for permit shall be consistent with the plans approved by the Board, modified in accordance with the conditions set forth in this Order. No building permit may be issued unless and until all conditions of approval that must be satisfied prior to permit issuance, as set forth in this Order, have been met.

The issuance of the approval does not relieve the applicant from obtaining all other required Municipal, County and/or State reviews and permits, including final zoning approval. If adequate handicapped access is not provided on the Board-approved plans, this approval does not mean that such handicapped access is not required. When requesting a building permit, the plans submitted to the Building Department for permit shall be consistent with the plans approved by the Board, modified in accordance with the conditions set forth in this Order.

If the Full Building Permit for the project is not issued within eighteen (18) months of the meeting date at which the original approval was granted, the application will expire and become null and void, unless the applicant makes an application to the Board for an extension of time, in accordance with the requirements and procedures of Chapter 118 of the City Code; the granting of any such extension of time shall be at the discretion of the Board. If the Full Building Permit for the project should expire for any reason (including but not limited to construction not commencing and continuing, with required inspections, in accordance with the applicable Building Code), the application will expire and become null and void.

In accordance with Chapter 118 of the City Code, the violation of any conditions and safeguards that are a part of this Order shall be deemed a violation of the land development regulations of the City Code. Failure to comply with this Order shall subject the application to Chapter 118 of the City Code, for revocation or modification of the application.
