TREE INVENTORY ON SITE


1. Veitchia montgomeryana (Montgomery palm tree) DBH 7", Spread 10', Height 22', this trees condition is good. This tree is on the south east corner of property, on ROW. Minimum 4' TPZ shall be installed to protect 4' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remove.



2. Veitchia montgomeryana (Montgomery palm tree) DBH 6", Spread 10', Height 21', this trees condition is moderate. This tree is on the south side of property, on ROW. Minimum 4' TPZ shall be installed to protect 4' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remain.



3. Veitchia montgomeryana (Montgomery palm tree) DBH 6", Spread 10', Height 23', this trees condition is fair. This tree is on the south west corner of property, on ROW. Minimum 4' TPZ shall be installed to protect 4' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remain.




4.Adonidia merrillii (Christmas palm tree) DBH 4", Spread 8', Height 15', this trees condition is fair. This tree is on the south east corner of property. Minimum 4' TPZ shall be installed to protect 4' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remain.



5.Adonidia merrillii (Christmas palm tree) DBH 4", Spread 8', Height 15', this trees condition is fair. This tree is on the south side of property. Minimum 4' TPZ shall be installed to protect 4' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remain.



6.Ptychosperma elegans (Solitaire palm tree) DBH 3", Spread 6', Height 14', this trees condition is fair. This tree is on the east side of property. Minimum 4' TPZ shall be installed to protect 4' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remove.



6A,B. Dracaena marginata (Dragon tree) DBH 6"ea., Spread 6'-7'ea., Height 10'-12'ea., these trees conditions are moderate. These trees are on the east side of property. Minimum 4' TPZ ea. shall be installed to protect 4' CRZ's of these trees and done under ANSI A-300 guidelines should these trees need protection during construction. These trees are scheduled to remove.






6C. Ficus benjamina (Wheeping Fig tree) DBH 4", Spread 7', Height 13', this trees condition is poor. This tree is on the east side of property. Minimum 6' TPZ shall be installed to protect 6' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remove.




7. Ficus benjamina (Wheeping Fig tree) DBH 9", Spread 20', Height 20', this trees condition is poor. This tree is on the north east corner of property.


Minimum 9' TPZ shall be installed to protect 9' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remove.




8. Ficus benjamina (Wheeping Fig tree) DBH 6", Spread 20', Height 20', this trees condition is moderate. This tree is on the north side of property. Minimum 6' TPZ shall be installed to protect 6' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remove.



8A. Ficus benjamina (Wheeping Fig tree) DBH 3", Spread 6', Height 16', this trees condition is moderate. This tree is on the north side of property. Minimum 6' TPZ shall be installed to protect 6' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remove.




9. Ficus benjamina (Wheeping Fig tree) DBH 6", Spread 15', Height 20', this trees condition is moderate. This tree is on the north west corner of property. Minimum 6' TPZ shall be installed to protect 6' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remove.




10. Ficus benjamina (Wheeping Fig tree) DBH 11", Spread 15', Height 20', this trees condition is very poor. This tree is on the north west corner of property. Minimum 11' TPZ shall be installed to protect 11' CRZ of this tree and done under ANSI A-300 guidelines should this tree need protection during construction. This tree is scheduled to remove.




TREE PROTECTION GUIDELINES (TPZ)
