

1760 LENOX AVE HISTORICAL ANALYSIS

HISTORICAL OUTLINE

1760 Lenox Avenue, located in Miami Beach, Florida, sits on a 7,500 square feet lot. The property is located in a single-family residential zoning designation, RS-4 with a Miami-Dade designated Folio number 02-3234-004-0230. It is situated in the Palm View Historic District. The existing property is a contributing historical structure and consist of a two-stories residence and a one-story guest house. The property was built in 1934 and designed by Architect Victor Hugo Nellenbogen. The style of the home can be described as Mediterranean Revival/Art Deco Transitional.

The Palm View Historic District exemplifies the swift pace of development in Miami Beach, spanning from 1915 to 1926. After the Alton Beach Realty Company, led by Carl Fisher, initiated the subdivision of the Palm View region in April 1920, the construction of numerous distinguished private homes promptly followed and persisted for the ensuing three decades. The unique Palm View area boasts a diverse and cohesive collection of Miami Beach's architectural styles, spanning from the 1920s to the present day. Within the proposed Palm View Historic District, there are ten distinct architectural styles represented, encompassing everything from Masonry Vernacular to Mediterranean Revival, transitioning through Med/Deco, Streamline Modern, and culminating in Post World War II Modern and Garden Apartment styles. Notably, the Mediterranean Revival style, in vogue during the city's initial major land development phase in the 1920s, dominates the district's architectural landscape. The buildings within the Palm View Historic District hold artistic significance in terms of their architectural form, special materials, intricate detailing, embellishments, interior design, and site features. Victor H. Nellenbogen along with a few other architects belonged to the well known architects whom crafted the 1920's private homes in this district.

Victor H. Nellenbogen designed Six residential homes in the Palm View Historic District:

1760 Lenox Avenue - 1934 Mediterranean Revival
1829 Jefferson Avenue - 1935 Mediterranean Revival
1026- 18th Street- 1936 Mediterranean Revival
1735 Michigan Avenue - 1936 Med/Deco Transitional
1815 Michigan Avenue - 1937 Med/Deco Transitional
1719 Lenox Avenue - 1940 Masonry Vernacular

The Palm View Historic District offers a compilation of architectural styles that collectively trace the historical progression of architectural design and construction in Miami Beach from the 1920s through the mid-1960s. The distinctive character of the Palm View neighborhood is defined by its array of detached, one- and two-story single-family dwellings, as well as low-rise apartment buildings enveloped by lush landscaping.

On 1760 Lenox Ave the existing structure displays a Mediterranean Revival/Art Deco Transitional style, designed by Victor H. Nellenbogen. This structure includes red clay tiled roof, a large span of windows on the front facade as well as arched window openings on the second story of the front facade. The new proposal aims to connect the original configuration of the existing two story structure and the existing guest house structure with a breezeway addition. A second story addition to the existing one story guest house with a carport/terrace surrounding the existing pool. Furthermore, the planned addition will result in cohesive connections and a seamlessly circulating floor plan for the existing and proposed structures.




1760 Ave_9A Sanborn Map_1947
