The applicant, LEV Montessori, 501(c)(3), located at 1701 Washington Avenue, Miami Beach, is requesting a Conditional Use Permit in order to operate a new daycare, the Muss Family Montessori School at Temple Emanu-El, for 25 children ages 2-6 at a facility located at the rear of the Temple, with a main entrance on James Avenue, according to the following sections of the Code:

#### Sec. 118-192. - Review guidelines.

- (a) Conditional uses may be approved in accordance with the procedures and standards of this article provided that:
  - (1) The use is consistent with the comprehensive plan or neighborhood plan if one exists for the area in which the property is located. Use is consistent with the neighborhood.
  - (2) The intended use or construction will not result in an impact that will exceed the thresholds for the levels of service as set forth in the comprehensive plan. The intended use will not exceed the levels of service as set forth in the Comp Plan.
  - (3) Structures and uses associated with the request are consistent with these land development regulations. The structure is existing and the use is consistent with the LDRs
  - (4) The public health, safety, morals, and general welfare will not be adversely affected. These will not be adversely affected
  - (5)Adequate off-street parking facilities will be provided.
  - The project proposes to restripe to provide a total of 9 parking spaces.
  - (6) Necessary safeguards will be provided for the protection of surrounding property, persons, and neighborhood values. All required safeguards will be provided.
  - (7)The concentration of similar types of uses will not create a negative impact on the surrounding neighborhood. Geographic concentration of similar types of conditional uses should be discouraged. Similar type uses do not exist within the immediate area.

A Conditional Use permit was approved at this location on July 25, 2006, under File No. 1776. It was issued to Touro College, as a school for adults. The proposed Muss Family Montessori School at Temple Emanu-El hours of operation are Monday to Friday from 8:00 a.m. 12:30 p.m. and 8:00a.m. to 3:00 p.m. A small group of kids stay for the after school program until 5:00 p.m. and many of the younger students only stay until 12:30 p.m.

Ms. Rebeca Krys will be operating the Muss Family Montessori. She has been a Montessori teacher and administrator since 1982, worked for Montessori School of Kendal 22 years until the school was sold. She was interviewed at the Cuban Hebrew Congregation to start a Jewish Montessori School and successfully opened their doors in 2004 and worked there until September 2016.

The applicant will be applying for variances for the drive aisles and setbacks from the HPB.


