As you know, this law firm represents Miami Beach Resort Owner LLC (the "Applicant"), the owner of the above-referenced property (the "Property"). Please allow the following to serve as the required letter of intent in connection with a request for Modification to the Historic Preservation Board (HPB) Order dated April 14, 2015 for file number: 7420.

Description of the Property. The Property is located within the RM-3, Residential Multifamily, High Intensity zoning district. It is identified by the Miami-Dade County Property Appraiser by folio number: 02-3223-002-0130. The buildings on the parcel comprise of approximately 446,889 square feet or 3.06 acres.

The Property is also located within the Collins Waterfront Local Historic District. This area contains numerous hotels and entertainment establishments.

The Miami Beach Resort, originally known as the Doral, was designed by Melvin Grossman and permitted in 1962 as a seventeen-story (17) story, four hundred twenty-three (423) unit hotel. The tower was designed to be fully encased by glass curtain walls, noted to be a "glass castle of continental elegance." Each hotel room is sheathed by an entire glass wall, allowing clear views to the City's skyline

Entrance to the Doral was gained through the port cochere located atop the vehicle drive, directly accessing the second floor of the hotel. The rear of the property housed a pool, two (2) L-shaped cabana structures and direct access to the beach. It became famous for its starlight room atop the building, overlooking the entire city-scape.

While the Property has maintained much of the original design, over the years it has come into disrepair, requiring substantial renovations associated with the 40-year re-certification. The Applicant is desirous of renovating the Property, while maintaining its historical character. To that end, the Applicant appeared before the HPB on April 8, 2014 and obtained an order for a certificate of appropriateness for partial demolition design and again on April 14, 2015. Refer to the Certificates of Appropriateness dated April 8, 2014 and April 14, 2015, attached hereto as Composite Exhibit A.

Description of the Development Program. The Applicant wishes to renovate the Property while maintaining its unique historic character. To that end, the Applicant previously obtained a certificate of appropriateness for certain renovations. The westernmost half of the 18th floor contains the Starlight Roof, while the eastern half provides another gathering area, bathrooms, storage and elevators. The Applicant sought to retain and to rehabilitate the Starlight Roof, which is located on the 18th floor of the tower. While working to complete the plans for the complete renovation of the property, an issue arose with current fire and life safety requirements. When originally constructed the egress requirements were not as stringent as they are now. Therefore, the Starlight Roof could have a greater occupancy without the need for additional means of egress, i.e. stairs. Under the current life safety standard, the occupancy of the space far exceed the egress capacity of the floor. Therefore, after a number of meetings with the Fire Chief and Planning Staff, the Applicant has come up with a solution to retain the Starlight Roof and reduce the occupancy of the floor. The Applicant is proposing to retain the southwest quadrant of the 18th floor, which is the most visible portion

of the roof as you drive north on Collins Avenue, as the Starlight Roof. However, the remainder of the floor would be turned into habitable rooms. This change would allow the retention of the most visible portion of the Starlight Roof, while creating a safe environment for all of the hotel's guests and visitors.

The Applicant is desirous of maintaining the historical character of the Property, while providing the much needed improvements and advents for the Property. This proposal does both those things. It also brings the Property into the 21st Century while celebrating its unique character and history.

Request. The Applicant is seeking a certificate of appropriateness for demolition and design. Section 118-395(b)(2)(d)(1) of the Code permits a structure to retain its existing setbacks and any existing parking credits if the following elements remain substantially intact, and are retained, preserved and restored:

- i. At least 75% of the front and street side facades;
- ii. At least 75% of the original first floor slab;
- iii. For structures that are set back two or more feet from interior side property lines, at least 66 percent of the remaining interior side walls; and
- iv. All architecturally significant public interiors.

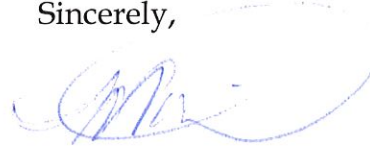
The proposed project meets the criteria stated above. The Applicant has taken every reasonable measure to preserve the Property and refrain from requesting unnecessary divergences from the Code. As such, the Applicant requests a recommendation for a Certificate of Appropriateness for Demolition and Design.

Conclusion: This Property will greatly benefit from the renovation as will the surrounding neighborhood. The introduction of habitable units on the 18th floor will allow for the continued use of the Starlight Roof and continue to provide an allure of the historic past of the building. 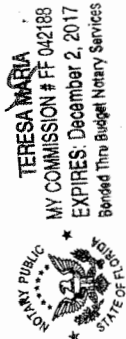

The applicant Miami Beach Resort Owner, LLC, filed an application with the City of Miami Beach Planning Department for a Certificate of Appropriateness.

The City of Miami Beach Historic Preservation Board makes the following FINDINGS OF FACT, based upon the evidence, information, testimony and materials presented at the public hearing and which are part of the record for this matter:

- A. The subject structure is classified as 'Contributing' in the Miami Beach Historic Properties Database and is located within the Morris Lapidus/Mid 20th Century Local Historic District.
- B. Based on the plans and documents submitted with the application, testimony and information provided by the applicant, and the reasons set forth in the Planning Department Staff Report, the project as submitted is not consistent with the Certificate of Appropriateness Criteria 'a' in Section 118-564(a)(1) of the Miami Beach Code, is not consistent with Certificate of Appropriateness Criteria 'a', 'b' & 'c' in Section 118-564(a)(2) of

the Miami Beach Code, is not consistent with Certificate of Appropriateness Criteria 'b', 'c' & 'g' in Section 118-564(a)(3) of the Miami Beach Code, and is consistent with Certificate of Appropriateness Criteria for Demolition in Section 118-564(f)(4) of the Miami Beach Code.

C. The project would be consistent with the criteria and requirements of section 118-564 if the following conditions are met:

1. Revised elevation, site plan and floor plan drawings shall be submitted to and approved by staff; at a minimum, such drawings shall incorporate the following:
 - a. The introduction of balconies shall be limited to the east elevation and the fifth and sixth floors of the north and south elevations of the tower structure with the exception of the recreation of the original balconies on the 17th floor of all elevations.
 - b. The proposed recreational areas located on the roof of the north ballroom, shall not be permitted.
 - c. The reconstructed original balconies on all four sides of the 17th floor shall have vertical picket railings, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
 - d. The vertical window mullions located between the precast piers shall have a white or off-white finish, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
 - e. The proposed glass railings located at the 4th level of the new amenities deck shall be setback a minimum of five (5) feet from the west edge of the roof deck, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
 - f. The recreated "Starlight Lounge" signage on the tower parapet shall recreate the original signage in materials, colors, style, detail, dimension, and location, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
 - g. The waterfall features located below the main lobby windows at both side of the porte cochere shall be restored, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
 - h. Final details of all exterior surface finishes and materials shall be required, including samples, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.



- i. A copy of all pages of the recorded Final Order shall be scanned into the plans submitted for building permit, and shall be located immediately after the front cover page of the permit plans.
2. A revised landscape plan, prepared by a Professional Landscape Architect, registered in the State of Florida, and corresponding site plan, shall be submitted to and approved by staff. The species type, quantity, dimensions, spacing, location and overall height of all plant material shall be clearly delineated and subject to the review and approval of staff. At a minimum, such plan shall incorporate the following:
 - a. Street trees shall be required along Collins Avenue, placed with a minimum 36" clear space between the tree trunk and the back of curb, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
 - b. Silva Cells in tree pits, with the City Standard black and white bound aggregate system and fertilization trench, irrigation, and two (2) up-lights per City standards, shall be required for all street and shade trees, in a manner to be reviewed and approved the Board.
 - c. The utilization of root barriers and/or Silva Cells, as applicable, shall be clearly delineated on the final revised landscape plan.
 - d. A fully automatic irrigation system with 100% coverage and an automatic rain sensor in order to render the system inoperative in the event of rain. Right-of-way areas shall also be incorporated as part of the irrigation system.
 - e. FPL transformers or vault rooms, backflow preventers and all other related devices and fixtures shall not be permitted within any required yard or any area fronting a street or sidewalk. Their location and how they are screened with landscape material from the right-of-way, shall be clearly indicated on the site and landscape plans in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
3. Satisfaction of all conditions is required for the Planning Department to give its approval on a Certificate of Occupancy; a Temporary Certificate of Occupancy or Partial Certificate of Occupancy may also be conditionally granted Planning Departmental approval.
4. In the event Code Compliance receives complaints of unreasonably loud noise from mechanical and/or electrical equipment, and determines the complaints to be valid, even if the equipment is operating pursuant to manufacturer specifications, the applicant shall take such steps to mitigate the noise with noise attenuating materials as reviewed and verified by an acoustic engineer, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.

5. The Final Order shall be recorded in the Public Records of Miami-Dade County, prior to the issuance of a Building Permit.
6. The Final Order is not severable, and if any provision or condition hereof is held void or unconstitutional in a final decision by a court of competent jurisdiction, the order shall be returned to the Board for reconsideration as to whether the order meets the criteria for approval absent the stricken provision or condition, and/or it is appropriate to modify the remaining conditions or impose new conditions.
7. The conditions of approval herein are binding on the applicant, the property's owners, operators, and all successors in interest and assigns.
8. Nothing in this order authorizes a violation of the City Code or other applicable law, nor allows a relaxation of any requirement or standard set forth in the City Code.

IT IS HEREBY ORDERED, based upon the foregoing findings of fact, the evidence, information, testimony and materials presented at the public hearing, which are part of the record for this matter, and the staff report and analysis, which are adopted herein, including the staff recommendations, which were amended by the Board, that the Certificate of Appropriateness is GRANTED for the above-referenced project subject to those certain conditions specified in paragraph C of the Findings of Fact (Condition Nos. 1-8 inclusive) hereof, to which the applicant has agreed.

PROVIDED, the applicant shall build substantially in accordance with the plans approved by the Historic Preservation Board, as determined by staff, entitled "Miami Beach Resort", as prepared by Kobi Karp Architecture and Interior Design, Inc., dated February 2014.

When requesting a building permit, the plans submitted to the Building Department for permit shall be consistent with the plans approved by the Board, modified in accordance with the conditions set forth in this Final Order. No building permit may be issued unless and until all conditions of approval that must be satisfied prior to permit issuance, as set forth in this Final Order, have been met.

The issuance of this Certificate of Appropriateness does not relieve the applicant from obtaining all other required Municipal, County and/or State reviews and permits, including final zoning approval. If adequate handicapped access is not provided on the Board-approved plans, this approval does not mean that such handicapped access is not required. When requesting a building permit, the plans submitted to the Building Department for permit shall be consistent with the plans approved by the Board, modified in accordance with the conditions set forth in this Order.

If the Full Building Permit for the project is not issued within eighteen (18) months of the meeting date at which the original Certificate of Appropriateness was granted, this Certificate of Appropriateness will expire and become null and void. If the Full Building Permit for the project should expire for any reason (including but not limited to construction not commencing and continuing, with required inspections, in accordance with the applicable Building Code), this Certificate of Appropriateness will expire and become null and void.

In accordance with Section 118-561 of the City Code, the violation of any conditions and

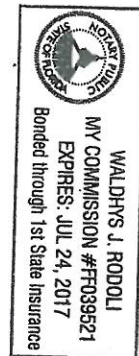

- A. A Construction Parking and Traffic Management Plan (CPTMP) shall be approved by the Parking Director pursuant to Chapter 106, Article II, Division 3 of the City Code, prior to the issuance of a Building Permit.
- B. The Applicant agrees that a project manager will be retained to ensure that all aspects of the development permitting and licensing processes are coordinated and consistent with the approved plans. The applicant agrees to submit the name and contact information for the project manager to the Planning Department within 90 days of the April 14, 2015

meeting. Failure to comply with this condition within the specified time shall result in notice and a hearing before the Board to extend the timeframe.

- C. A copy of all pages of the recorded Supplemental Final Order shall be scanned into the plans submitted for building permit, and shall be located immediately after the front cover page of the permit plans.
- D. The Supplemental Final Order shall be recorded in the Public Records of Miami-Dade County, prior to the issuance of a Building Permit.
- E. Applicant agrees that in the event Code Compliance receives complaints of unreasonably loud noise from mechanical and/or electrical equipment, and determines the complaints to be valid, even if the equipment is operating pursuant to manufacturer specifications, the applicant shall take such steps to mitigate the noise with noise attenuating materials as reviewed and verified by an acoustic engineer, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
- F. Satisfaction of all conditions is required for the Planning Department to give its approval on a Certificate of Occupancy; a Temporary Certificate of Occupancy or Partial Certificate of Occupancy may also be conditionally granted Planning Departmental approval.
- G. The Supplemental Final Order is not severable, and if any provision or condition hereof is held void or unconstitutional in a final decision by a court of competent jurisdiction, the order shall be returned to the Board for reconsideration as to whether the order meets the criteria for approval absent the stricken provision or condition, and/or it is appropriate to modify the remaining conditions or impose new conditions.
- H. The previous Final Order dated April 8, 2014 shall remain in full force and effect, except to the extent modified herein.
- I. The conditions of approval herein are binding on the applicant, the property's owners, operators, and all successors in interest and assigns.
- J. Nothing in this order authorizes a violation of the City Code or other applicable law, nor allows a relaxation of any requirement or standard set forth in the City Code.

IT IS HEREBY ORDERED, based upon the foregoing findings of fact, the evidence, information, testimony and materials presented at the public hearing, which are part of the record for this matter, and the staff report and analysis, which are adopted herein, including the staff recommendations, which were adopted by the Board, that the Certificate of Appropriateness is GRANTED and the Variance request is DENIED for the above-referenced project subject to those certain conditions specified in Paragraph I, II, III of the Findings of Fact, to which the applicant has agreed.

PROVIDED, the applicant shall build substantially in accordance with the plans approved by the Historic Preservation Board, as determined by staff, entitled "Miami Beach Resort" as prepared

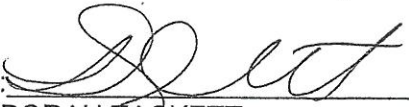

Failure to comply with this **Order** shall subject the Certificate of Appropriateness to Section 118-564, City Code, for revocation or modification of the Certificate of Appropriateness.

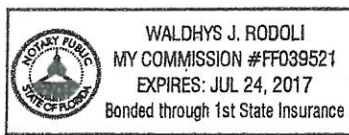

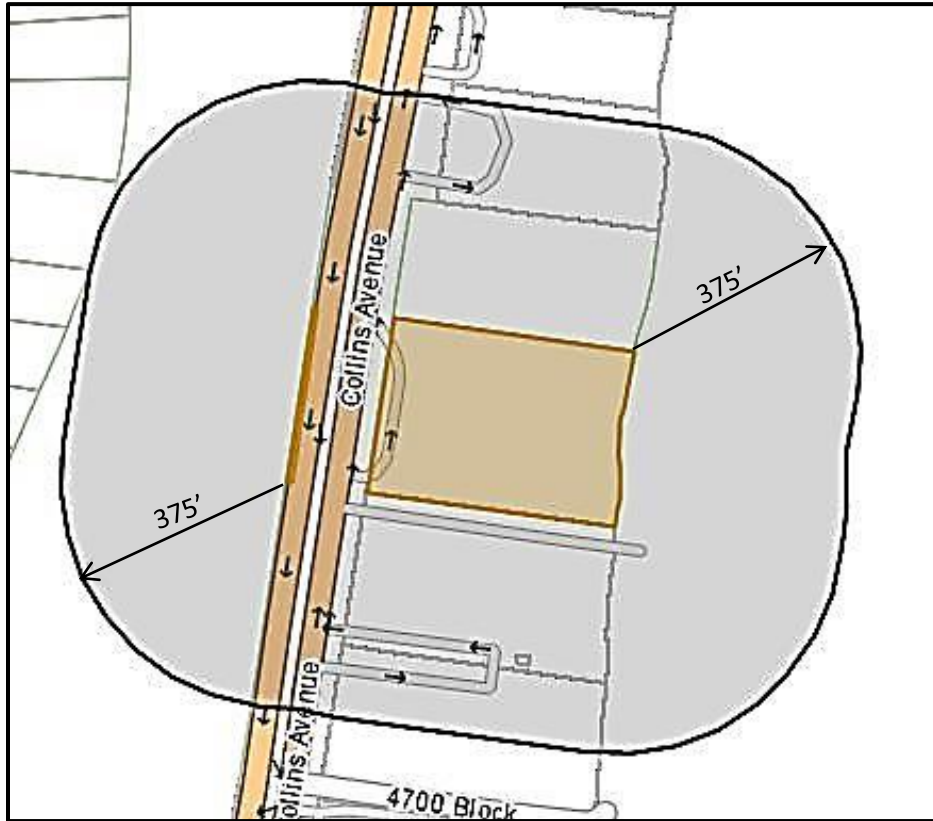
