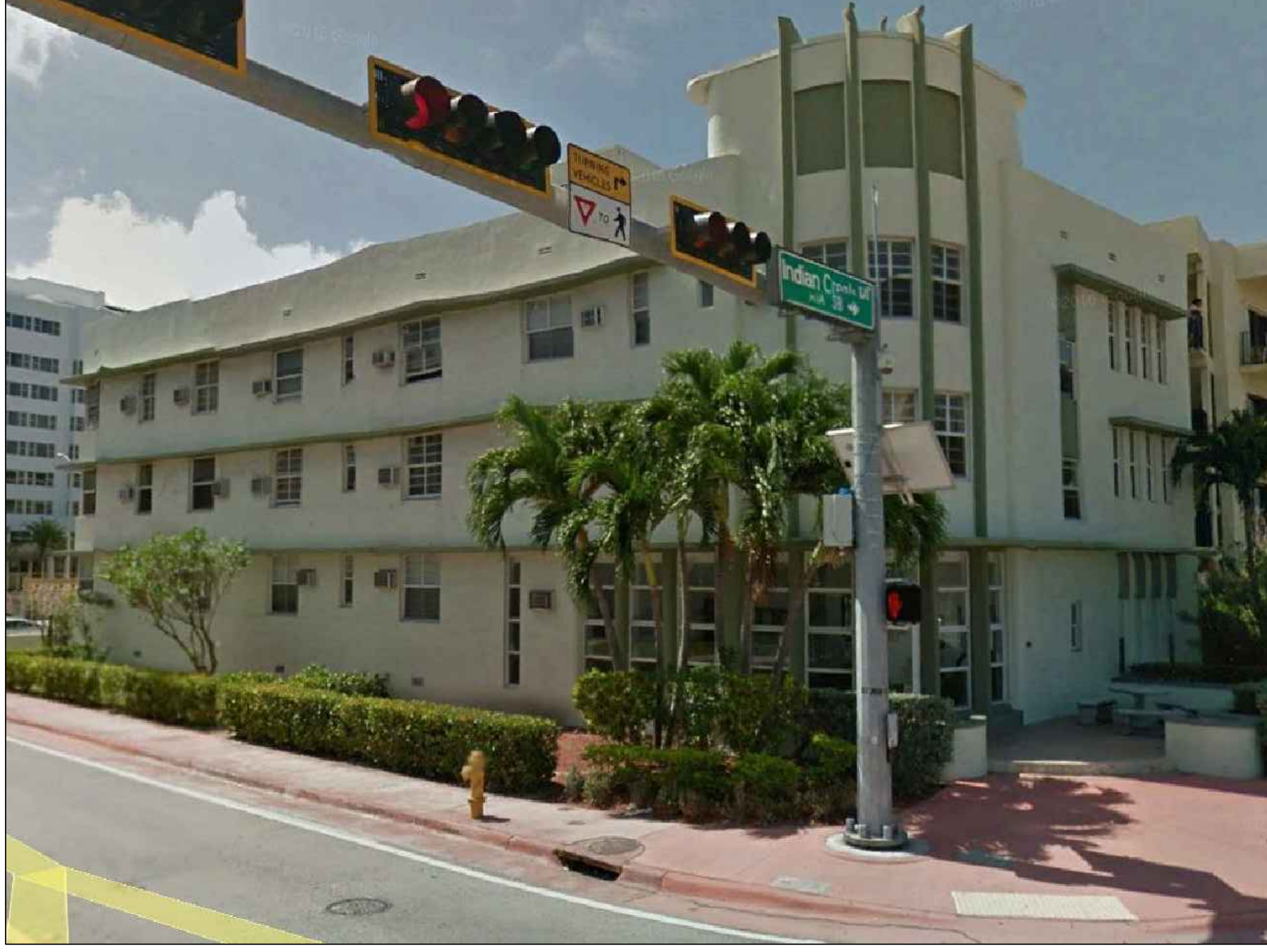

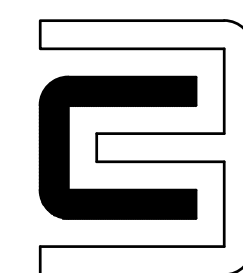


EXISTING BASEMENT LEVEL

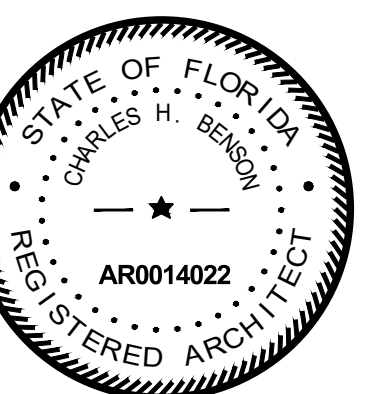

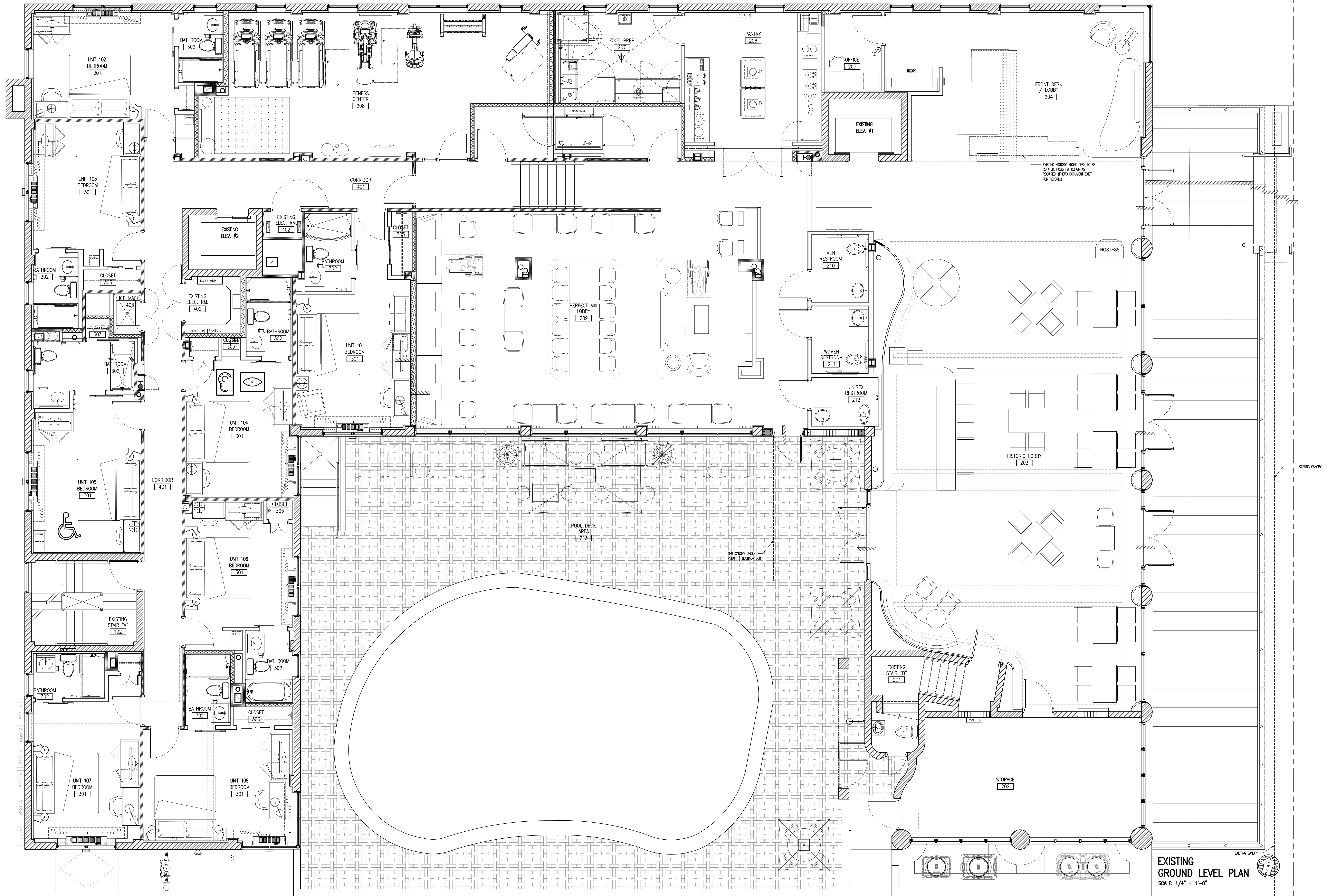

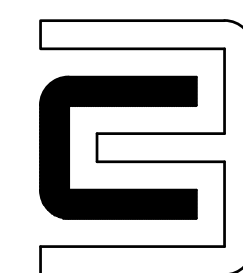


EXISTING

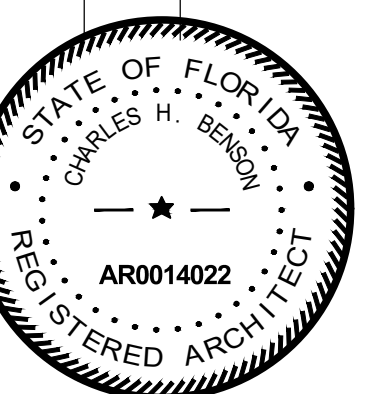

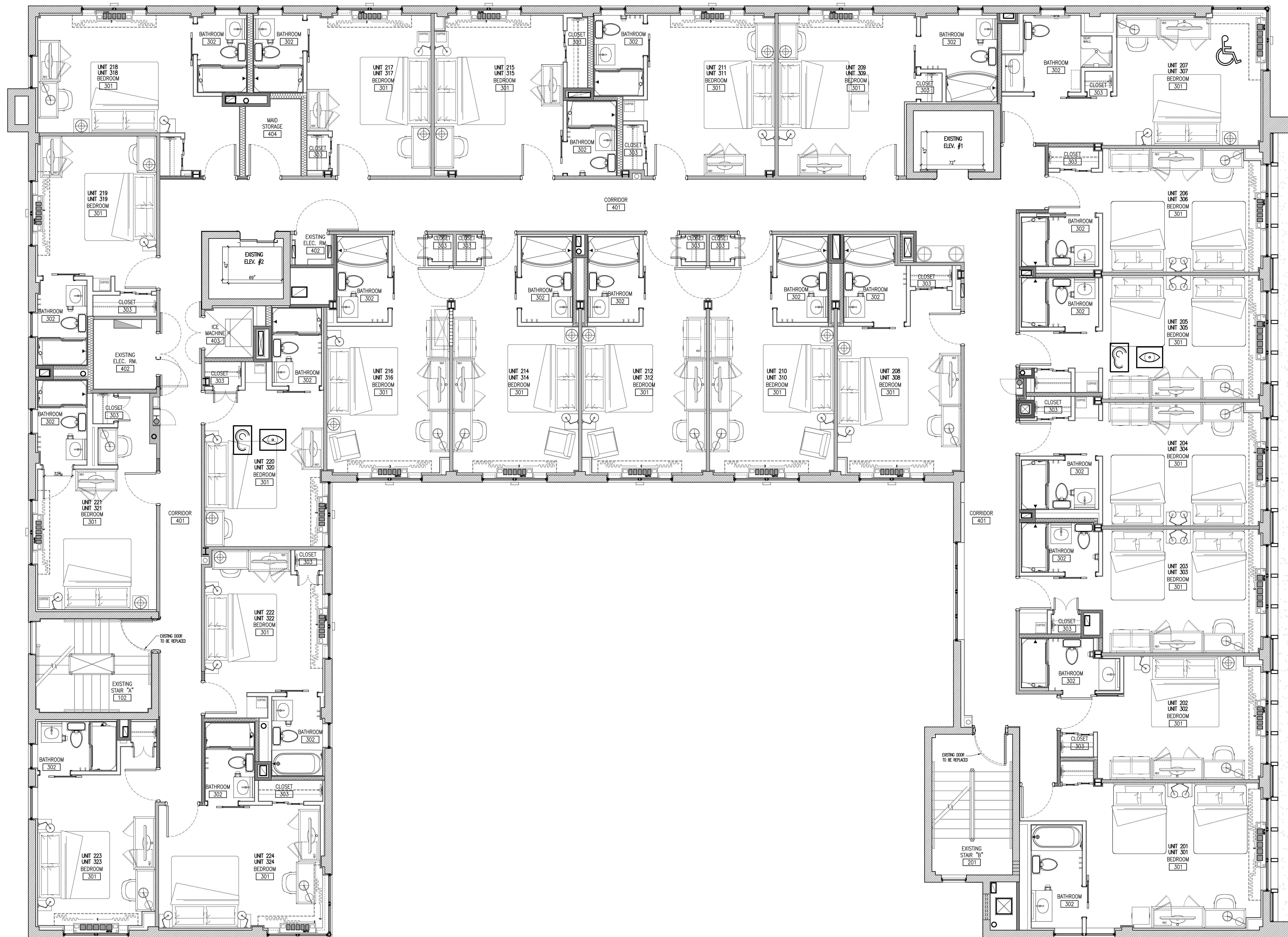

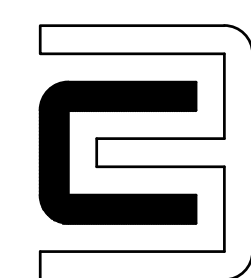
EXISTING

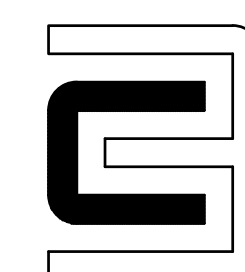


EXISTING ROOF LEVEL PLAN

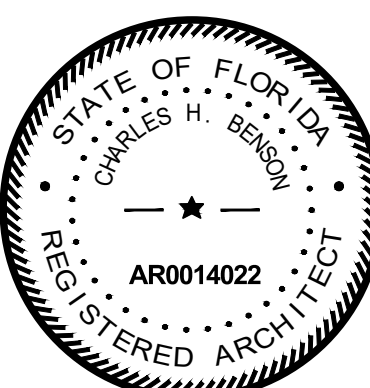


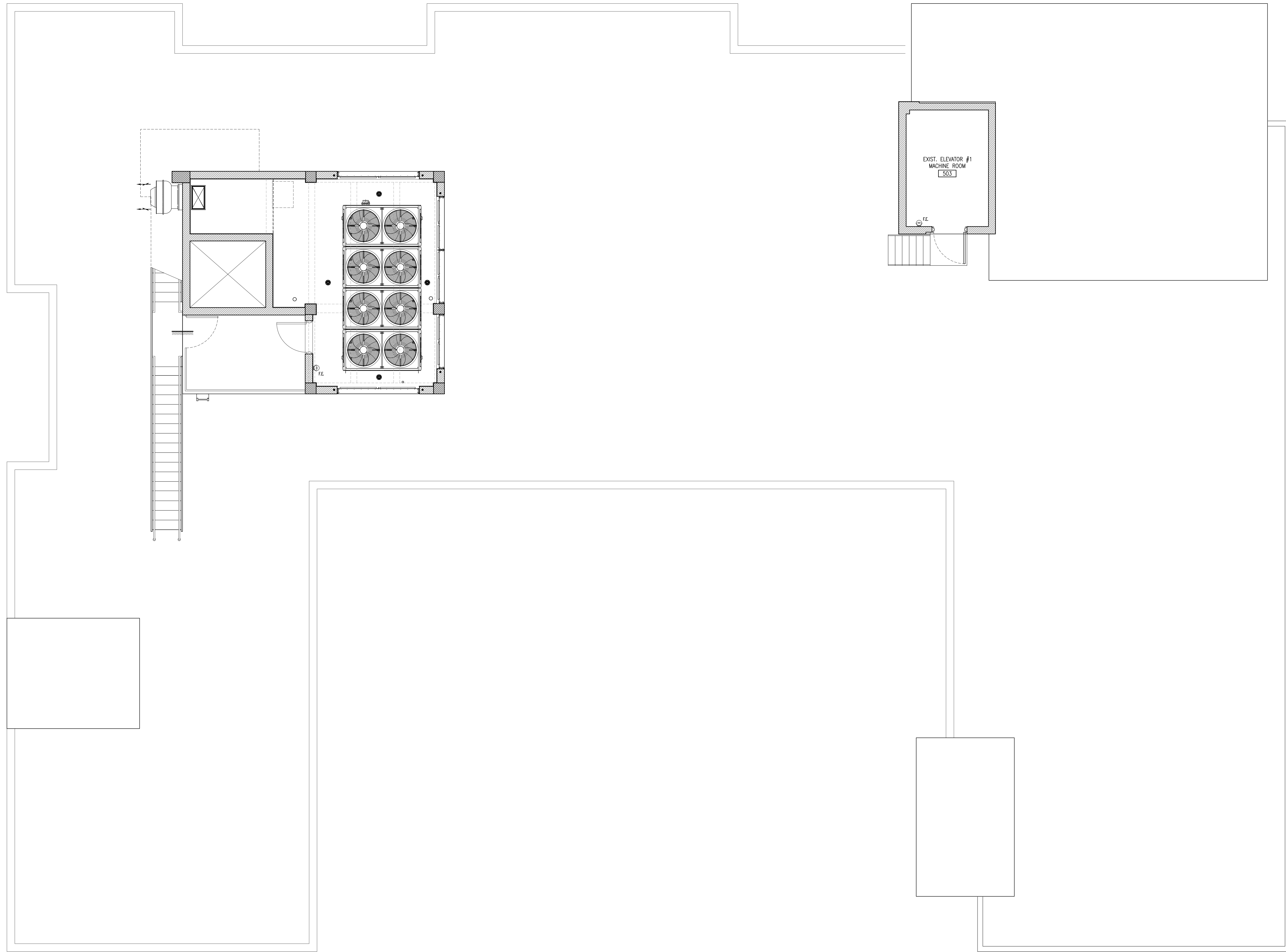

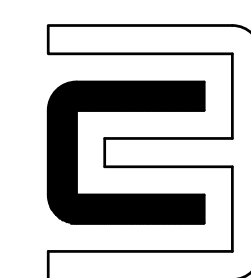


EXISTING INTER. ELEV.

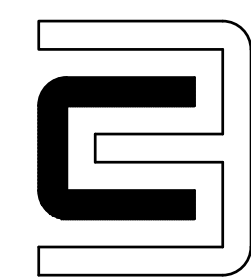




EXISTING EAST ELEVATION

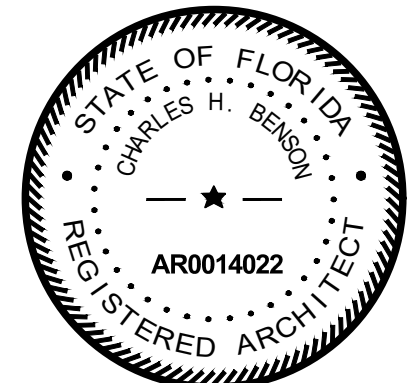


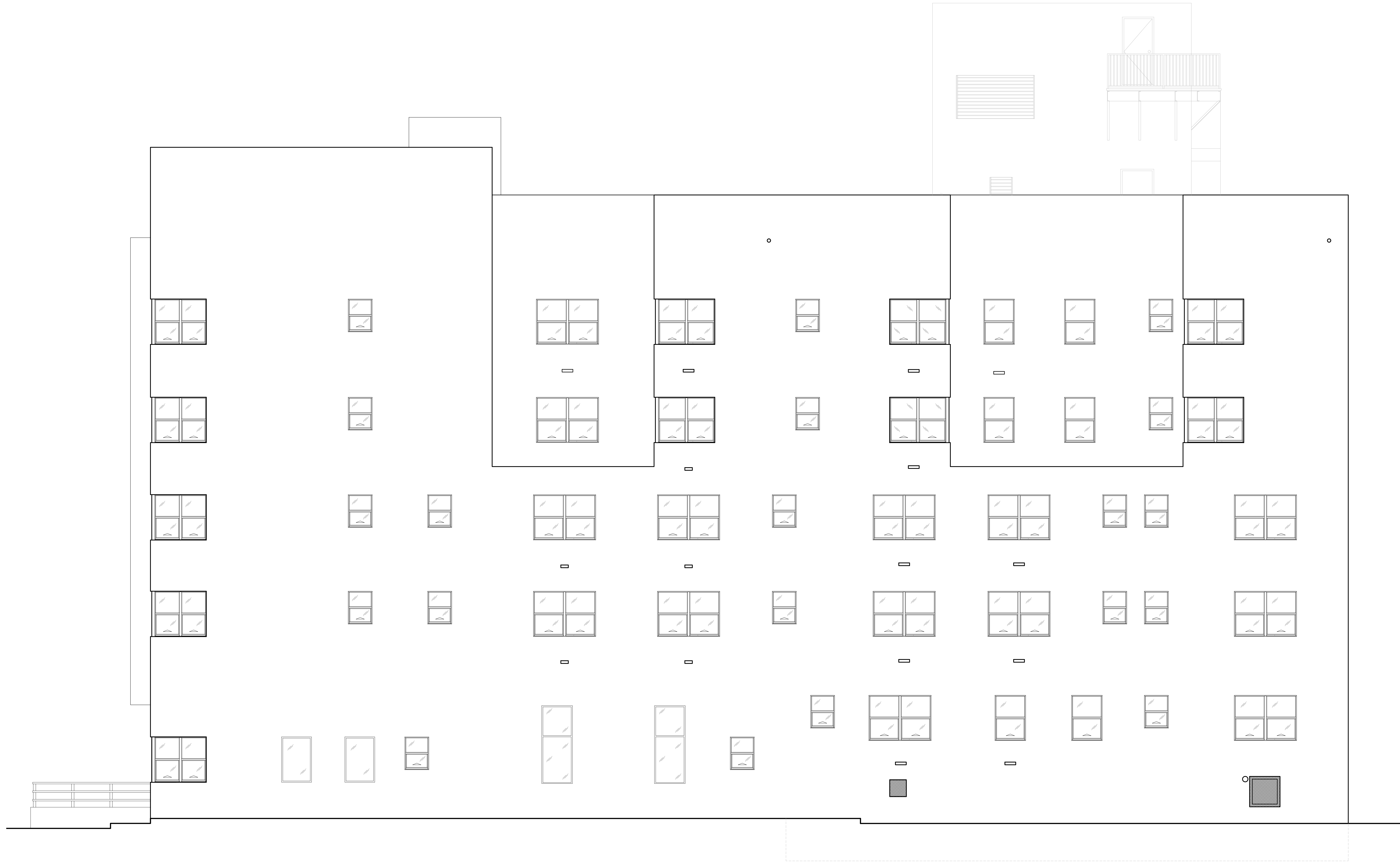

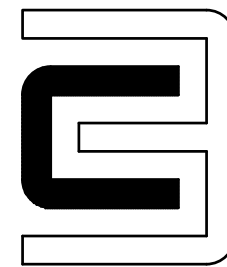




EXISTING NORTH ELEVATION

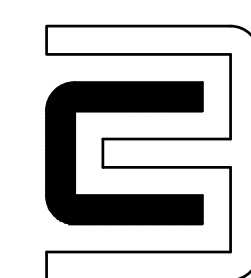
EXISTING WEST

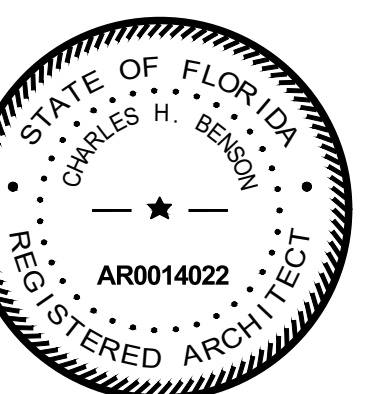

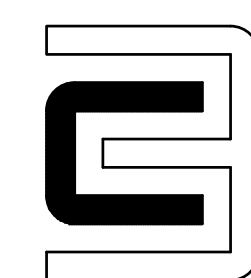




EXISTING SOUTH ELEVATION

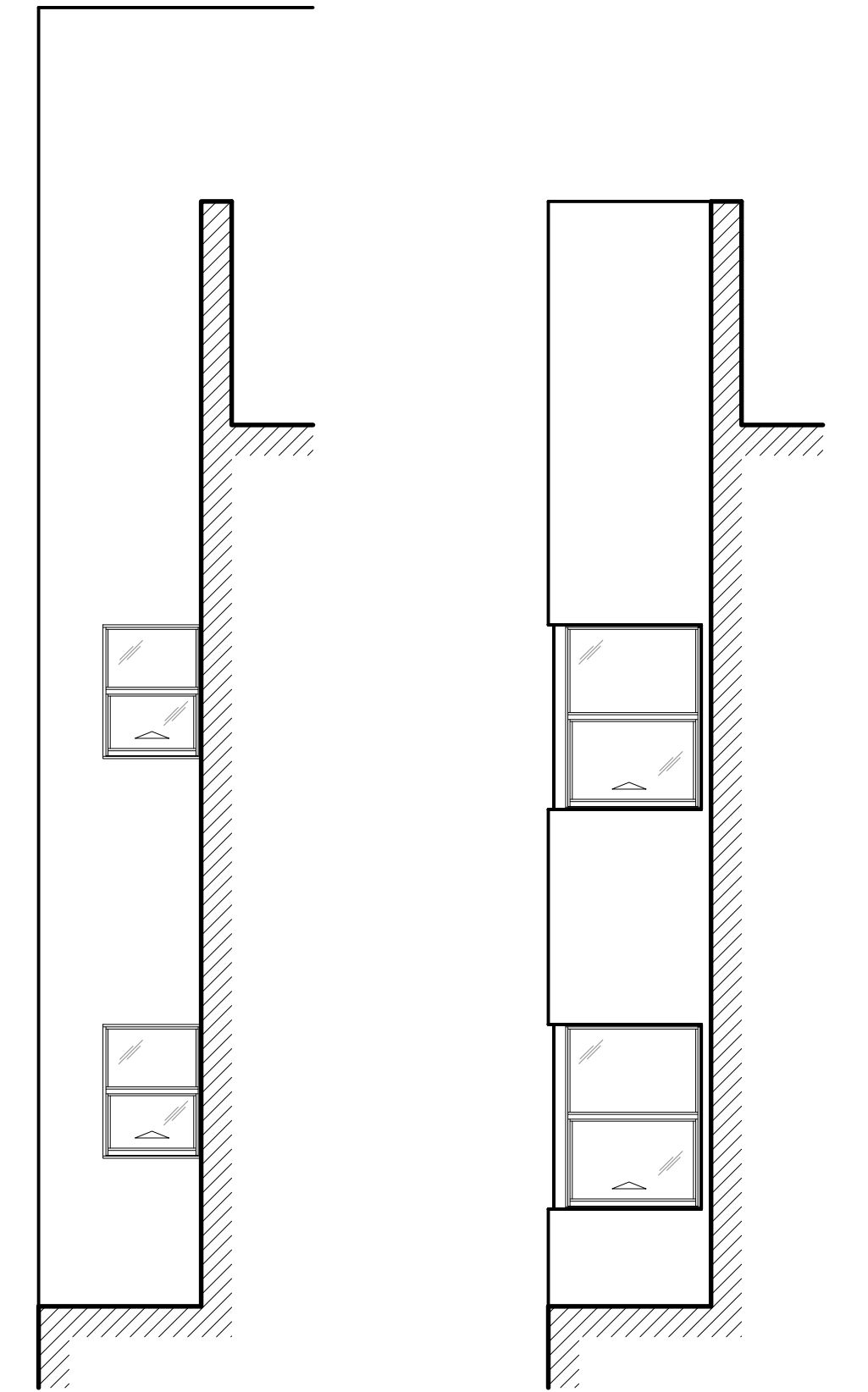




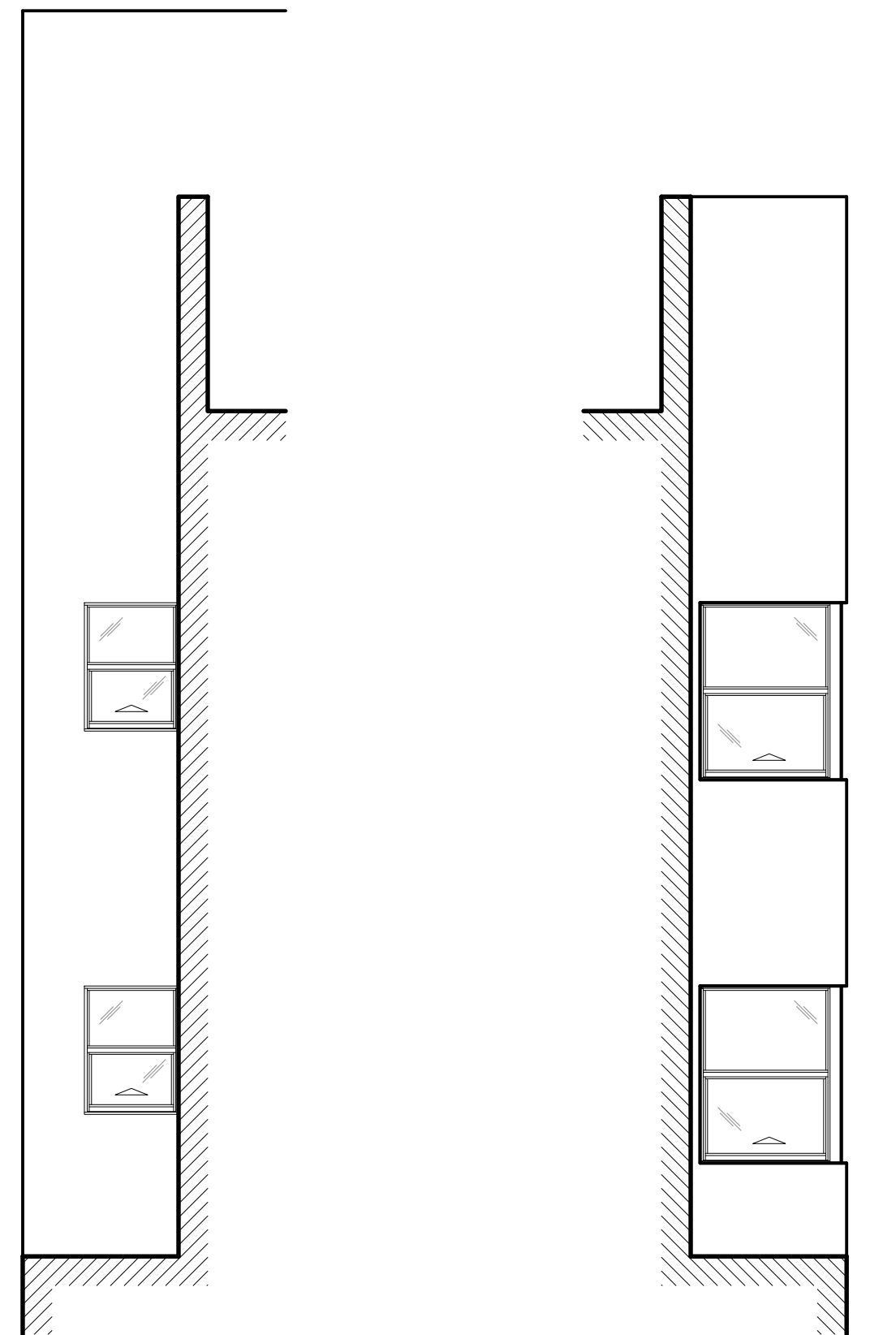
EXISTING

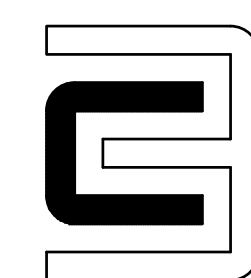




DEMOLITION NORTH ELEVATION

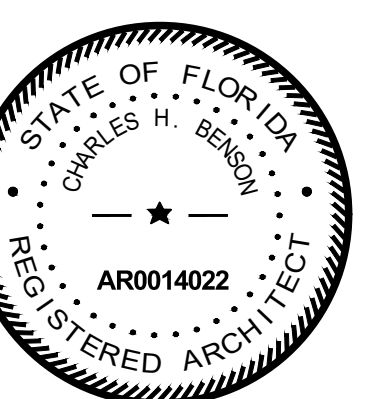

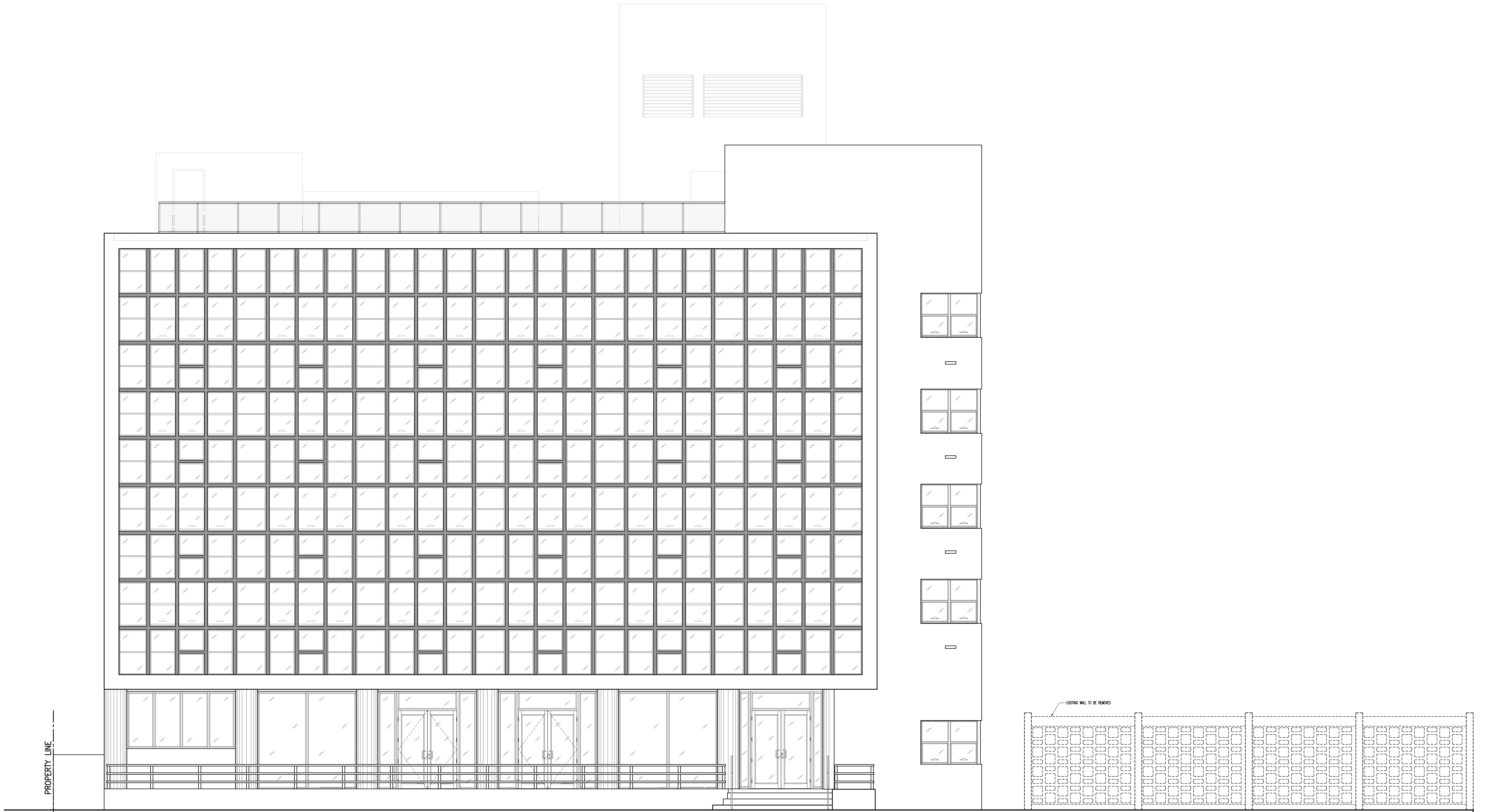

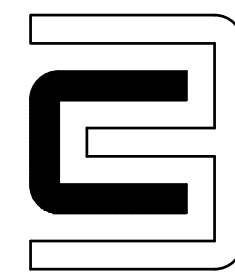




DEMOLITION EAST ELEVATION

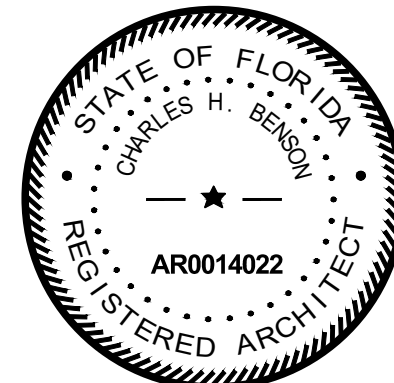

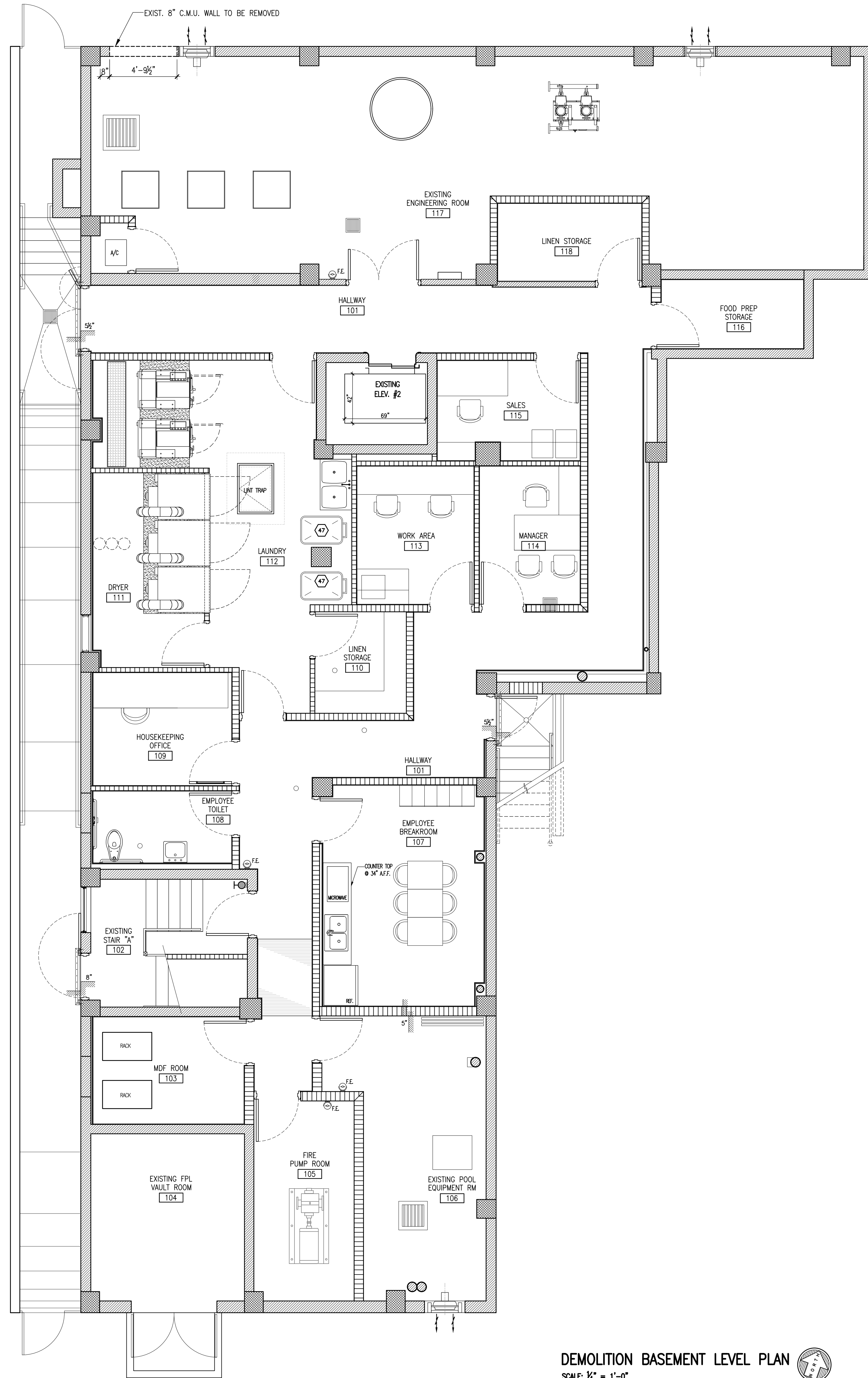

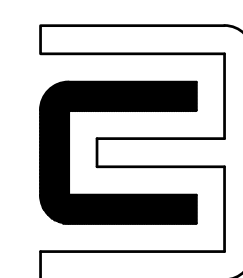


DEMOLITION BASEMENT LEVEL PLAN
